# JACKSONVILLE WOMEN'S GOLF ASSOCIATION GENERAL MEETING MINUTES - December 12, 2022

### **NEW BUSINESS:**

**Proposed amendments to JW Constitution:** Linda Hoffman discussed the proposed amendments to the JW Constitution that will accurately reflect the current Board positions.

Golf Genius: Athena Ballas asked about the cost of Golf Genius going forward and how that cost would be paid. Helen Short said the cost for Golf Genius next year would be \$3600 and at this time Membership Dues would adequately cover the cost. There was some discussion regarding why we are using Golf Genius. Linda Hoffman explained that prior to Golf Genius, we had a website and Google program to manage events. After soliciting volunteers to manage that program with no success, we had to find a new option. Golf Genius makes the Pro's job easier, the Club Reps jobs easier, and scoring is easier. A committee evaluated other software programs, and Golf Genius was the best option.

Handicap Chair: Athena also asked if we were eliminating the Handicap Chair position and how we would monitor if Members were not posting. Linda Hoffman explained that with the Golf Genius program, all JW Member scores are automatically posted eliminating the need for someone to monitor. If a Member suspects that another Member is not posting outside JW they should bring it to the attention of the JW President who will contact the Club Rep and ask them to investigate. JW is not responsible for monitoring scores outside our activities, but will certainly try to assist if there is a problem.

**NOMINATING COMMITTEE:** Linda Hoffman announced the nominating committee for the new Executive Board would be led by Shari Zeimetz. Four volunteers came forward: Teresa Barrett, Jody Clark, Caryn Kasik and Cindy Peterson.

The motion was made and the meeting was adjourned at 2:10 p.m.
