**General Meeting Minutes - December 11, 2024**

**OPENING** - President Vickie Galpin opened the meeting at Marsh Landing CC by thanking club rep Tina Shupe and the Marsh Landing staff.

**Prize (Teresa Barrett)** - Teresa recognized the winners of the Sarah Shelly Tournament, Maria Ayala and Joey Whelan. She also updated the membership on the trophy cases. There are six trophy cases (donated from World Golf Hall of Fame) located in Orange Park. All trophies, with

the exception of the three Majors, are housed in the cases along with historical information and photos. Member Suzy Rountree has designed and donated all of the signage. A date will be set for members to gather and visit if they wish. A video will also be created and posted to the website for those that are not able to attend.

**NEW BUSINESS:**

Vickie asked for volunteers for the nominating committee for next season's officers (Linda Hoffman is the chair). One member emailed her interest in being on the committee so only three volunteers were needed. Helen Short, Susie Fonde and Tama Caldabaugh will join Shan Giordano (email volunteer) in rounding out the committee.

Tama Caldabaugh addressed the membership about an FSGA opportunity in NE Florida. The Senior Women's amateur will be played at Deercreek March 17 and 18. They will have several divisions available for signup and will play from 4700-5700 yards depending on division.

Therese Quinn has offered to host a seminar (approx 30 minutes) for the members, focusing on the mental game and course management with a follow up question and answer period. Vickie asked for a show of hands from members as to their interest. There are a lot of members interested. It was mentioned that there may be a nominal \$10 donation, all proceeds going to our charitable endeavor for the season, On Course Foundation. We will proceed and coordinate a date with Therese Quinn.

Charitable Endeavor - Shauna Snyder coordinated our charitable endeavor this season, On Course Foundation. She was overwhelmed by the generosity of our members who have thus far donated \$8264.00. The 50/50 total proceeds were \$980 so half will go to Irene and half will go to On Course Foundation. Shauna has requested that the majority of our donations be directed towards events taking place in Duval, Clay, St Johns and Nassau counties (our JWGA member counties).
