

**JWGA Anniversary Tournament  
General Meeting - Queen's Harbour  
March 04, 2026**

**Meeting was called to order at 2:15**

**Welcome** – President Deb Eady welcomed everyone to the celebration of JWGA's 98<sup>th</sup> anniversary. She thanked Shari Zeimet, the Pro Shop and Staff at Queen's Harbour Yacht and Country Club for setting up such a nice event.

**Secretary Report** – Carol Williams - Reading of the minutes was waived; minutes were approved.

**Treasurer** – Cyndi Riley said that the Treasurer's Report was available on the table. She advised that there is roughly \$11,000 in the Operational Fund and approximately \$2000 left in Hole in One fund and that the organization is in good financial shape. Treasurer's Report was approved. In response to a question regarding the Hole in One funds, it was clarified that for over 80 participants, the payout is capped at \$750. Otherwise, the amount is \$500.

**Major Tournament Chair** – Linda Hoffman - Registration for our 3 week Championship will open on March 11. The first tournament is scheduled on April 8 at King and Bear followed by Deercreek (April 15) and Marsh Landing (April 22). The Championship will be run the same as last year with a Championship Division, a Senior Division and a Super Senior Division.

On November 1, 1927, Winnie Holmes, the first president and a group of women with a passion for golf met and established the JWGA dedicated to camaraderie, competition and promotion of women's golf in the community. The first play day was held eight days later at the municipal golf course. At the time, there were no powered golf carts. Players either used pull carts or carried their bags (wearing dresses). I would like to thank these brave women and all JWGA members since for keeping it going.

President Eady then introduced the Past Presidents in attendance and thanked them for their service to JWGA: Delores Adams, Shan Giordano, Sach Price, Suzanne LaPlante, Shari Zeimetz, Linda Hoffman and Vicki Galpin.
